This letter serves as a report for the activities of the Citizen's Review Panel for the Heart of Georgia – Altamaha region.

The following individuals were selected to serve on this Citizen's Review Panel: Kathryn Fisher of Cochran, Roy Herrington of Baxley, Phil Best of Dublin, H. G. Yeomans of Swainsboro and Billy Trapnell of Metter. The panel met initially at the Macon GDOT office on March 15th. At this meeting we were given instructions as to our responsibilities and how the TIA program was designed to work. We also elected officers for the Panel: Billy Trapnell, Chairman and Kathryn Fisher, Secretary. Ms. Fisher has since resigned from the CRP and we are awaiting a new appointment to fill her position. Future meetings were established to coordinate with the regular meeting of the Regional Commission (fourth Thursday of each month, other than December). The panel would meet quarterly (March, June, September and December). Due to there being no Regional Commission meeting in December, the Panel voted to meet in Baxley, at the City Hall on December 10th, 2013 at 5:00 PM.

Minutes of the meetings held during this year, 2013, as well as reports on the projects completed are included with this letter. These minutes cover the actions taken by the Panel in reviewing the projects approved in the TIA program.

Mike Dover, his staff, as well as other GDOT have been very helpful to our communities and this panel in accomplishing the duties assigned, to improve transportation in Region 9. Likewise Brett Manning, Ex. Director of the Heart of Georgia-Altamaha Regional Commission, and his staff have been vital to the success of this program.

We feel that the three projects which have been completed met the needs and desires that were anticipated by their respective communities.

CALL TO ORDER

The TIA Citizens Review Panel meeting for June 27, 2013, was held at the Mount Vernon/ Montgomery County Community Service and Senior Citizens Center in Mount Vernon, Georgia. The meeting was called to order at 5:33 P.M. by Chairman Billy Trapnell, Mayor of Metter. Chairman Trapnell welcomed everyone to the meeting and called on Roy Herrington to give the invocation.

INTRODUCTION OF GUESTS

Chairman Trapnell asked everyone to introduce themselves.

GDOT UPDATE

Chairman Trapnell stated that as he understood it the Citizens Review Panel responsibilities were to review the requested changes and the projects as they are completed. They're also required to review the administration of the projects and programs on the approved investment list.

Chairman Trapnell then called on Mike Dover, TIA Administrator, Georgia Department of Transportation (GDOT) to address the Panel. Mike explained that this was actually the second meeting. The first meeting was facilitated by GDOT and held on March 15 in Macon with all three Citizens Review Panels in the regions that passed the T-SPLOST. He let them know that legislatively the Citizens Review Panel is an independent entity that gauges how well GDOT performs the duty of delivering the projects on the improved investment lists. The Citizens Review Panel is required to meet at least three times a year and deliver a report at the end of the year to the legislature grading how well GDOT performed their duties in delivering the TIA projects.

Mike then explained about Band changes. He stated that were not officially addressed in the Regional Commission Regional Roundtable or in the legislation. He let them know that after conversing with several local governments it appeared that several projects needed to be changed within the bands. At that time GDOT was required to deliver every project on time and under budget so that made them very reluctant to entertain any band changes. GDOT was hesitant because this list of projects was presented to voters and they voted based on the schedule presented and the budget. They talked with the Attorney General's office and put together a process to allow band changes. He let them know that GDOT had put together a procedure to allow band changes. A local government must justify the selected band change request including the benefit that will be realized by changing the bands. The proposed change should also be budget neutral to other bands. He explained that one of the things GDOT looks at when they get a band change is, "does this benefit the public by moving this project forward?" Another thing they look at is how this affects cash flow. He let them know that one of the responsibilities of the Citizens Review Panel is to review and comment on Band changes. He explained that for the band changes the process should go as follows: local government to request change; Regional Commission Advisory Committee makes recommendation to GDOT for band change and notify the Chairman of the Citizen's Review Panel; Citizen's Review Panel reviews and comments (stage the Citizen's Review Panel is at now); and GDOT approves.

Mike then went over revenue projections versus actual collections. He let them know that the State Economist developed revenue projections before the vote was taken. The projections were over a ten year period. There have been four months of collections January, February, March, and April. He explained that collections are a lag of two months between collections for any particular month is reported. We are six months into actual collection but have only seen what four months looks like. Collections are down 10 – 20 percent as compared to what the projections expected. GDOT staff has had discussions with the Department of Revenue as well as the Georgia State Finance Investment Commission about what to expect, and if anything they would advise about collections. They told them that we are only four months into a ten year program and it's too early to tell the outcome. The pace of the program will be determined by of the collections. He let them know that they would keep everyone informed on the pace of the program.

Mike stated that GDOT is letting projects and coordinating with local governments. He told them they had let two projects on last Friday funded by Transportation Investment Funds. He stated this was a milestone from the program. The first project was 22 resurfacing streets in Laurens County and the other project was in Randolph County located in the River Valley Regional Commission area. He noted that GDOT had awarded those two projects this morning. He also told them that the resurfacing projects actually were lower than the estimated amount with the exception of one project. In the July letting they have two contracts with about 18 roads in Appling and Wayne counties. He stated that these would have to be let for bid and hopefully these bids will come in at something they can award.

Mike then advised that if a local government wants to delivery their own projects that they have to apply with GDOT for local delivery.

Chairman Trapnell asked if anyone had any questions. A question was then asked by Glenwood Mayor G.M. Joiner, Jr. His question was how do you determine in what order these projects are let. Mike stated that if the project is ready and if the local government is going to deliver that these would be the first to be delivered. Mayor Joiner asked what he meant by the project being ready. Mike told him that ready means estimates have been completed and bid packages have been put together. He also stated that they needed to know what the scope was for the project.

Bill Torrance, City Manager, City of Vidalia asked would it be appropriate for him to go ahead and ask about a band change. Chairman Trapnell said he could that it would help the panel in making a decision. Bill stated that they don't have a lot of resurfacing projects that their projects are building roads or repairing roads. He let them know that Adams Street was the most critical road and it was located in Band 2. He said that they have three roads in Band 1 that don't exist and they want to swap Adams Street into Band 1. He let them know that Adams Street was ready to go and he had his engineer with him there at the meeting. He also let them know that the City of Vidalia could fund the project but wanted to make sure that when the TIA monies come in they can be reimbursed. Mike explained that as soon as the Citizen's Review Panel sent their request in to GDOT they would be ready to issue approval of the band changes. Kelvin Seagraves asked if they had a projected timeline for the approval of the band changes. Mike informed him

they would have the first submittals, which were submitted back in April, would be approved within two weeks.

James Canady, Emanuel County, asked with the revenues being lower than expected are we going to have a shortfall down the line with changing projects within bands. Mike told him that is why they set up a process and procedure to follow.

Kelvin Seagraves, Vidalia's engineer, asked did the sales tax collections go for ten years or until the projected revenues were collected. The answer was whichever comes first.

TIA COMMUNICATIONS

Chairman Trapnell then called on Jill Goldberg. Jill explained that for the past month or so they have been working on a new TIA webpage. She stated that this webpage would have all the projects listed, what band they are in, and where that project is in the process. She also stated they are working with local media to get the information out about the status of the projects. This website should be ready by mid-July.

TIA PROJECT MANAGEMENT & CASH FLOW

Chairman Trapnell then called on Tony Sanger, Region Project Manager with AECOM, under contract with GDOT. Tony explained that one of the things they look at when making band changes is that the change has to be budget neutral in total and how they impact cash flow. He stated they are currently checking the validity of the projects making sure all of the projects and costs are correct. He stated this process for all three bands should be complete by August or September. After that is completed they will have a complete capital cost cash flow for this program from start to finish. He told them that they cannot let more work out than they have money to pay for. He let them know that in the construction contracts the TIA payment language in the contracts let the contractors know that if during the course of construction if the TIA program would not have the money to pay you we are going to give you a 90 day notice that the money will be gone. This could impact bid amounts. Expected revenues must retain a comfortable cushion above expected costs for committed projects to maintain proper management and cash flow, or that could impact bid costs as well.

Mike let them know that the first project completed through the TIA program was completed in Toombs County. The project was the Georgia State Route 130 turn lane.

REVIEW OF REQUESTS FOR PROJECT BAND CHANGES

Chairman Trapnell stated that there had been seven requests for project band changes. Dublin Mayor Phil Best, stated that the band changes have been requested by the local governments and the Advisory Council had sent in a letter recommending the band changes. He saw no reason for the Panel not to approve these recommendations, or to discuss them further. Chairman Trapnell stated that all the projects seemed worthy of the band changes. The Citizen's Review Panel signaled consent for the requested band changes.

ADJOURN

There being no further business, a motion to adjourn the TIA Citizens Review Panel Meeting at 6:25 P.M. was accepted unanimously.

CALL TO ORDER

The TIA Citizens Review Panel meeting for September 26, 2013, was held at the Mount Vernon/Montgomery County Community Service and Senior Citizens Center in Mount Vernon, Georgia. The meeting was called to order at 6:03 P.M. by Chairman Billy Trapnell, Mayor of Metter. Chairman Trapnell welcomed everyone to the meeting and called on Mayor Phil Best, City of Dublin, to give the invocation.

INTRODUCTION OF GUESTS

Chairman Trapnell asked Mike Dover, TIA Administrator, Georgia Department of Transportation (GDOT) to introduce his staff. Mike introduced Tony Sanger, Program Manager, GDOT.

APPROVAL OF JUNE 27, 2013 MEETING MINUTES

Chairman Trapnell stated that the Minutes for the June 27, 2013 TIA Citizens Review Panel Meeting had been mailed out to all Members and he would entertain a motion for approval. A motion was made by Phil Best and seconded by Roy Herrington to approve the Minutes, as mailed. The motion passed with no opposition.

REVIEW OF REQUESTS FOR PROJECT BAND CHANGES

Chairman Trapnell stated that there had been another group of request for band changes. Brett Manning, Executive Director, HOGARC stated that the Regional Advisory Council had approved the band changes and that GDOT had also reviewed. A motion was made by Roy Herrington and seconded by Phil Best to approve the Group 2 band changes. The vote passed unanimously.

GEORGIA DEPARTMENT OF TRANSPORTATION TIA STATUS UPDATE

Chairman Trapnell then called on Mike Dover to update the Panel. Mike then went over a handout he passed out. He informed them that GDOT had let 45 projects. In the HOGARC area they were 4 resurfacing projects in Wayne County; 15 resurfacing projects in Appling County; and 22 resurfacing projects in Emanuel, Johnson, Laurens, Montgomery, and Treutlen counties. He also let them know that they had been very busy with local agreements. He informed them that they had executed 14 local agreements and had 86 projects approved.

Mike then explained to the Panel about the Revenues and Collections. He informed them that the Heart of Georgia Altamaha Region was 18% behind in revenue verses collections. He stated that GDOT is being patient because this only reflects 7 months of collections so far. GDOT still believes that they can deliver all Band 1 projects within the budget. He let them know that the local governments have to stay within their budgets. He stated that after the first of the year they could access the program and see where things stood.

Mike then stated that the Citizen Review Panel has reports that are required for the legislature. He informed them that they had some ideas on what the reports should consist

of. The reports should include the reviewing benefits of completed projects; update each project expense; and a report on the review of the Panel's actions.

Mike let the Panel know that they had some concerns about Band 1 changes. He stated that they had to put a deadline on Band 1 changes because they were one-third of the way through the Band and still had concerns on delivering the projects for Band 1. The other concern they have is the local deliver of the projects. They have received 108 local requests. He stated that GDOT has to make final decisions on who delivers the projects. If they have not sent in a request then GDOT will assume they are to deliver the projects.

Chairman Trapnell then asked Mike about the actual bids that were being received compared to the project costs. Mike stated that the bids were below the projected costs. Chairman Trapnell asked would this help make up the shortfall. Mike stated that it would help but it was too early to know for sure.

Chairman Trapnell then asked if anyone had any more questions. Brett stated that he would get with Mike and set a deadline for the last of the Band 1 changes.

Mike also let them know that they have a website available. He stated that on the website they will have before and after photos showing citizens what their one percent sales tax funded. He stated they would also like photos of projects that the local governments used their discretionary monies for. Mike stated they are currently working with the Georgia Department of Corrections on creating a sign showing when a road is funded by the one percent sales tax. Brett stated that he had recently seen a Montgomery County paper and it had a road that had been paved with the discretionary monies and had a sign stating "this is your tax dollars at work."

WEBSITE DEMONSTRATION BY GDOT

Chairman Trapnell then called on Tony Sanger, Program Manager, GDOT to give a demonstration on the website. Tony then explained how to navigate through the website. Chairman Trapnell asked what the web address was. Tony stated it was www.ga-tia.com.

Bryan Rogers, County Administrator, Laurens County thanked GDOT for their help each time he has contacted them.

Tony then introduced Tony Collins, Local Liaison for the Heart of Georgia Altamaha Region, to the Citizens Review Panel. He let them know that this was someone local that the governments could contact.

OTHER BUSINESS

Chairman Trapnell informed the Panel that the HOGARC Regional Council did not have a December meeting but the Citizens Review Panel needed to meet in December. After some discussion it was decided that the meeting would be held at City Hall in Baxley on December 10, 2013 at 5:00 p.m.

ADJOURN

There being no further business, a motion to adjourn the TIA Citizens Review Panel Meeting at 6:51 P.M. was accepted unanimously.

CALL TO ORDER

The TIA Citizens Review Panel meeting for December 10, 2013, was held at City Hall in Baxley, Georgia. The meeting was called to order at 4:59 P.M. by Chairman Billy Trapnell, Mayor of Metter. Chairman Trapnell welcomed everyone to the meeting and called on Roy Herrington, to give the invocation.

INTRODUCTION OF GUESTS

Chairman Trapnell asked Mike Dover, TIA Administrator, Georgia Department of Transportation (GDOT) to introduce his staff. Mike introduced Tony Sanger, TIA Program Manager; Tony Collins, Local Liaison for HOGARC area; Jill Goldberg, Communications/Media Manager; and Tim Matthews, TIA Regional Coordinator. Chairman Trapnell then asked the other guest to introduce themselves. Brett Manning, Executive Director, HOGARC introduced his staff, Rafael Nail, Assistant Executive Director/Planning Director, and Michelle Brown, Senior Secretary/Public Information Coordinator. Brett also introduced Wyatt Nail, Rafael Nail's son, as a Boy Scout working on his Eagle Scout rank; Andrew Johnson, Consultant, Construction Materials Services, Inc.; Lee Lewis, County Manager, Appling County Board of Commissioners

APPROVAL OF SEPTEMBER 26, 2013 MEETING MINUTES

Chairman Trapnell stated that the Minutes for the September 26, 2013 TIA Citizens Review Panel Meeting had been mailed out to all Members and he would entertain a motion for approval. A motion was made by Roy Herrington and seconded by Phil Best to approve the Minutes, as mailed. The motion passed with no opposition.

GEORGIA DEPARTMENT OF TRANSPORTATION TIA STATUS UPDATE

Chairman Trapnell then called on Mike Dover to update the Panel. Mike stated that we have come a long way with the TIA program. He then updated the Panel on revenues. Mike stated that he knew everyone was concerned about the revenues. He stated that they had recently met with the Department of Revenue and the State Economist. He let them know that we are below 18% of what was expected but there is nothing that can be done about that. He stated they will manage the program accordingly and make adjustments to the program as needed to make it a success. He let them know that even though we are 18% below, we are 82% more than we had this time last year. He informed them that the three regions that the TIA program passed in had \$106 million more dollars than they had last year. He also let them know that 25% of that money goes to the local governments for them to spend accordingly. A question was asked by Chairman Trapnell on the varying amounts in the collections. Mike explained that because some file electronically and others file quarterly this would make a difference in the collections.

REVIEW OF YEAR END REPORT ON HOGARC REGION PROJECTS

Mike explained that they are getting projects out. He stated that they had established an unwritten prioritization. He let them know that the blended projects would get priority. He stated mainly because you have to protect the federal money that comes with the blended projects. He stated they had already let one in Dodge County and in June would

let another for the Dublin Bridge. The second priorities will be when the local government delivers the projects. The third priority will be the projects delivered by GDOT. He let them know that they are 41 resurfacing projects currently taking place in Baxley and Jesup. Another round of projects is scheduled for this spring. He let them know that they would be having a groundbreaking in Dodge County for the Eastman Bypass. This blended project included about \$6 million from federal money and \$1.7 million from TIA money.

Mike stated they have a couple of initiatives going on. One of those is an email blast. He stated there is not a lot of content but it usually has three or four topics. He asked them to send in photos of before and after to help paint a picture of the ten years.

Mike let them know that they have spent the past year developing policies and procedures. He let them know that in 2014 they would see more projects because they have gotten contracts and are ready to receive invoices from local governments that are delivering projects.

Mike then talked briefly about Ms. Fisher's resignation. He let them know that the Speaker of the House is responsible to name a replacement. He believes they should name a replacement sometime in January.

Mike then talked about Band Change request. Mike stated that GDOT is looking closely at any changes. He stated the changes need to be justified. If the local government does not provide justification the changes will not be granted.

CITIZEN REVIEW PANEL DISCUSSION ON COMPLETED PROJECTS AND REPORTING REQUIREMENTS

Chairman Trapnell then stated that he started drafting the cover letter with Mike's assistance. He stated he didn't bring a copy of the letter but he would email to everyone to look over and let him know if any changes need to be made. He let them know that they would also need a copy of the minutes from tonight's meeting to go along with the report.

Mike then addressed the Panel on reporting requirements. He let them know that the HOGARC collections through October 31, 2013 for projects on the approved investment list were \$16.89 million. He stated that they had approved 77 local applications for HOGARC region. They have executed 23 agreements between GDOT and the local governments totaling \$12.7 million for local delivery of Band 1 projects. He stated they have 41 resurfacing projects going on right now totaling over \$1.9 million and one federally blended project, the Eastman Bypass with \$1.7 million TIA funds. The Department is currently performing preliminary engineering activities on the remaining band 1 projects within the region that they will deliver. They feel confident they can deliver all of the projects within the allotted time. He also let them know that three projects have been completed and the project summaries were attached.

Mike stated that the Report needed to include the Summary of Active Projects and money spent on projects, which they provided. He also stated that a Summary of Activities of the Citizens Review Panel needs to be included. He stated they should include a cover page

and the meeting minutes from all Citizens Review Panel meetings. When this report is completed it needs to be uploaded to the TIA website by December 31, 2013.

A motion was made by Roy Herrington and seconded by Phil Best to accept the TIA Annual Report. The vote passed unanimously.

Rafael Nail stated that if anyone wanted to see a resurfacing project in Baxley there was one located behind city hall. Tony Collins gave an update on the paving projects. He stated that a local contractor was resurfacing the streets in Appling and Wayne but that striping still needed to be done on 70% of the streets. He stated they should be finished in the next two weeks.

OTHER BUSINESS

Mike let the Panel know that they are going to be sending out a survey to get feedback from the local governments. He stated the survey's would include things like what are you doing with your discretionary money. They would also like photos to go along with what you spent your discretionary money on. They will also send out a customer service survey. This survey will let them know how they are doing as far as meeting the needs of the local governments.

Chairman Trapnell asked if anyone else had anything to bring before the Panel. Brett Manning wanted to thank GDOT for all the work they have done. He also let them know that we had two more band changes. Brett stated we would need to have another meeting to review these two changes. After some discussion it was decided to have a meeting sometime in February.

ADJOURN

There being no further business, Mayor Trapnell thanked GDOT and the Regional Commission staff and wished everyone a Merry Christmas. A motion to adjourn the TIA Citizens Review Panel Meeting at 5:39 P.M. was accepted unanimously.
